INVITATION FOR BIDS

LITTLE PAPIILLION CREEK CHANNEL STABILIZATION PROJECT

The Board of Directors of the **Papio-Missouri River Natural Resources District** will receive sealed bids for the construction of Little Papillion Creek Stabilization Project per District adopted purchasing regulations and specifications on file in the principal office of the District, 8901 South 154th Street, Omaha, Nebraska 68138-3621.

The Work consists of stabilizing 9 sites on the existing east and west banks of Little Papillion Creek through placement of rock riprap fill (8 sites) and installation of rock filled trenches (1 site).

Upon Issuing Office's receipt of payment, printed Bidding Documents will be sent via the prospective Bidder's delivery method of choice; the shipping charge will depend on the shipping method chosen.
