Meeting Minutes June 6, 2024

1. Introductions
 - a. The meeting began at ~10:05 am with introductions. There were 13 Partners in attendance.
2. South Sarpy Stormwater Inspections Update – JEO Consulting
 - a. Ryan Joe (JEO Consulting) gave an overview presentation on the SSWP SW Inspections contract, which the SSWP first entered into with JEO in 2019 and which expires on January 31, 2025.
 - b. Ryan Joe took questions from the Partners on the contract.
 - c. The Partnership will determine the course of action for the contract in its August meeting.
3. 2024 Interlocal Agreement Status
 - a. To date, the Papio NRD, City of Springfield, City of Gretna, City of Papillion, and City of Bellevue have brought the 2024 Interlocal Agreement to their respective boards/councils and passed the Agreement. Sarpy County has the Agreement planned for their June 25th meeting.
 - b. Ian Ghanavati (Papio NRD) reminded all the Partners to send the executed signature page for their jurisdiction to him when possible.
4. Watershed Management Plan Report
 - a. A full draft of the Watershed Management Plan Report has been completed by HEI and has been made available for the Partners to review.
 - b. Comments on the Report are requested by July 12th, 2024.
 - c. Sara Mechtenberg (HEI) gave an overview of the report and answered the Partners questions.
5. Grade Control Implementation
 - a. The current status of the SSWP website was reviewed and the Partners were reminded that the Grade Control Guidance Document is complete and available



on the website. The website Grade Control Reimbursement Request Form was also reviewed and website feedback was requested. The Partners requested that submittal boxes for more detailed location information be included (cross-streets and/or parcel numbers). Further updates to the website as a whole are planned following adoption of the 2024 Interlocal Agreement.

- b. It was confirmed that those in attendance at the meeting would be the ones who would coordinate on any reimbursement requests.
6. Next Meeting: Thursday, August 1st
- a. The Partnership was originally scheduled to meet on July 4th – this meeting is cancelled and there is no meeting planned for July.
